# Letter from the President

As the President of the Board for Partners for Clean Streams, and the Maumee RAP Advisory Committee Chair, it's my honor to personally thank you for your support and involvement in 2011.

This past year was a very, very busy and exciting time for us. PCS added new staff and embarked on new initiatives that will demonstrate our ability to implement complex restoration projects. And, as always, the dedication and commitment of our friends and neighbors was perhaps most evident when we had nearly 730 people turn out for our 15th Annual Clean Your Streams Day! Meanwhile, despite a sluggish economy, many of our business partners continued their support in 2011; even a few new ones joined us, allowing PCS to maintain all of its programs.

In addition to welcoming several new staff members this year, PCS was also selected by the NOAA and US EPA to receive another Great Lakes Restoration Grant, as part of the \$475 million Great Lakes Restoration Initiative. PCS is privileged to be one of the "Job's Challenge" partners selected to administer an \$800,000 grant to put people to work through a CCC-style "Maumee Corps." This will provide more on-the-ground restoration projects in our region that will bring the rivers and streams closer to "fishable and swimmable." I am excited that PCS is so strongly positioned for growth and progress in 2012 and beyond.

The months ahead will be equally, if not more exciting, for PCS as we continue to work closely with the Boy Scouts to undertake the stream, lake, and habitat restoration work at Camp Miakonda. As if that wasn't enough, PCS will continue to work with the community and with the Ohio EPA to identify the priority projects that would move our region closer to fishable, swimmable, and drinkable as we update and re-invigorate our region's watershed plan (or roadmap). Please consider joining or renewing your membership and financially supporting us as we continue to work towards cleaner and healthier waterways for our families, your families, and their families to come. We couldn't have developed such solid footing without our innumerable partners, donors, and volunteers. So thank you, again.

## Letter from the Executive Director


The years just keep speeding by. It may be hard to believe, but in the spring of 2012, PCS will be 5 years old. And a busy, busy 2012 will be well underway.

PCS Financial Snapshot for 2011 and Looking Ahead to 2012 This financial snapshot shows that PCS is prudently managing resources in a difficult economic time and has been able to continue supporting all of our programs. Thanks to a financial reserve cautiously managed over the last several years, a slight difference in income and expenses was easily absorbed. In fact, we have hired three staff people this year (primarily grant funded), a huge increase in staff working towards healthier waters and their connected habitats. The challenge in 2012 will be working towards securing new resources that will enable PCS to maintain this level of staffing in 2013 and beyond.

In addition to the large Great Lakes Restoration Initiative Grant from the US EPA from last year for a stream bank and habitat restoration project at Camp Miakonda, PCS has been selected to administer an \$800,000 "Jobs Challenge" grant through NOAA and US EPA. The focus is to put people to work on various ongoing and smaller habitat restoration projects, providing a boost in jobs as well as improved habitat in the region.

PCS anticipates spending much of 2012 focusing on these two large habitat restoration projects, as well as enhancing all of our ongoing annual volunteer opportunities. For the two-year Ottawa River wetlands and habitat restoration project at Camp Miakonda, we will continue working closely with the Boy Scouts to reduce erosion along the river and the two tributaries that run through their property, and on creating and enhancing wetlands around the lake. We will also create fringe habitat in and around the lake and allow the lake to support fish once again. Future Scouts, in three to five years, should be able to experience Lake Sawyer and the diversified habitat in many meaningful ways, while learning about stream bank restoration, fish, plants, and insects!

As you can see from the graphics, we'd like to increase the amount received in individual and business donations so that PCS will become more self-reliant and position the organization to better leverage future grants. PCS aims to multiply every dollar from private donations with at least three dollars from grants and foundations, and to always look for in-kind resources to lower our expenses, so that private donations stretch even farther. In this challenging economic time, PCS is even more grateful for those members and businesses that have been able to continue supporting us as we work to improve water quality, habitat, and our overall quality of life for our families and their families to come. # Clean Streams Partner Award

This year's award goes to Matt Horvat and Steve Pollick for raising awareness of the Maumee River through their 130-mile canoe trip from Fort-to-Port on the Maumee.



Matt Horvat is the TMACOG Maumee Watershed Coordinator. Matt worked with the Maumee RAP Committee through TMACOG for many years. He also worked as the Conservation Specialist for the Lucas Soil and Water Conservation district for six years. Matt participated in the Boy Scouts of America as an Eagle Scout and was a Scout Leader for the Swan Creek District. He and his wife, Shelly, have three children.

Steve Pollick has been The Blade Outdoors Editor since 1971. For years, he has written about removing trash from the streams near his home, inspiring others to join him in taking ownership of their environment. In 1984, Steve took a canoe trip up the Maumee River, and wrote about it in The Blade. Last year, he made a return trip and documented the comparisons between then and now, illustrating the differences he'd noted over that span of time.

Together, Steve and Matt canoed over 130 miles from Fort Wayne to Toledo, exploring upstream stretches of the Maumee River. Friends joined them occasionally to provide moral support and supplies. A group from Partners for Clean Streams met up with them to finish the remaining eight miles of the trek. All along the way, Steve filed written reports to The Blade, while Matt posted video for TMACOG on YouTube™ and Facebook. What they saw and reported daily raised awareness of the river and natural environment near and far. For their efforts, they were worthy recipients of the 2011 Clean Streams Partner Award.







### Events Youth Patch Day Workshop, March 6th, 2011

PCS Youth Patch Day is designed to educate youngsters about this area's fresh water supply and how they can help keep those sources clean and abundant. It begins with an annual Patch Workshop in March or April. Youth participate in at least five activities in order to meet all the requirements needed to earn their patch. A PCS Patch Program booklet is also available for individuals or groups that would like to complete the requirements on their own. In either case, area youth wear their patch with great pride, knowing they can now take ownership of their local waterways.

7 Program Assistants: Older children who helped chaperone, took younger children to the restroom, handed out cards to groups, and collected and distributed coats. Each received a small appreciation gift. Most had been through the program before.

79 Youth (primarily Boy and Girl Scouts): Completed the 3-hour program and earned patches.

28 Adults: Chaperoned and received information about PCS.

113 Patches Awarded: Some were given to adults who completed the activities; others went to participating children.

97 Give Water a Hand Tip Card Packs: Distributed to adults and children. Included promotional items for wildlife-oriented organizations in the area. The Tip Cards offer ideas for water conservation.

### Give Water a Hand IV: Storm Drain Stenciling (SDS)

The former Maumee RAP Storm Drain Stenciling Program has been revamped and updated by Partners for Clean Streams as the fourth installment of the Give Water a Hand Program. The new version allows groups, organizations or individuals to partner with local jurisdictions to mark storm drain inlets. This marking informs the public that storm drains lead straight to local waterways and do not get "cleaned" by a treatment plant. Participating in Storm Drain Stenciling helps protect Lake Erie, our area's primary source of drinking water.

### 7th Annual Get the Lead Out!

Get the Lead Out! is an in-stream and streambank cleanup that collects fishing line and lead from the Maumee River, as well as garbage from its shoreline. Anyone can participate—fishing buddies, church groups, families and friends. Just call PCS to register. We'll provide the supplies, maps, tools—almost everything you need. 58 pounds of lead sinkers and hooks have been collected in 7 years. This year, 6 sites along the Maumee River were cleaned, covering one and a half milesincluding the Buttonwood area and Grassy Island in the Maumee River. Three groups participated: Fort Meigs Sertoma, 10 participants (new this year) Toledo ZOOTeens, 48 participants Boy Scout Troop 62, 13 participants (lead by an Eagle Scout)
