Partners for Clean Streams was awarded a grant from the National Fish and Wildlife Foundation in late 2015. This grant supported additional focus on marine debris removals and outreach and education. We increased the stream cleanups, especially with small groups focusing on specific sites, and continued our successful Clean Your Streams Day program. In 2016, for Clean Your Streams, 960 volunteers removed 26,136 pounds of trash from over 31 miles of rivers. We also engaged new partners, such as the Wood County Engineer's Office, and a few community groups.

Partners for Clean Streams continued supporting the Maumee Area of Concern Advisory Committee (MAAC) and its activities with a grant from Ohio EPA. We planned meetings, continued improving an online public data management tool, and organized numerous outreach, education, and public involvement activities. We held a water quality workshop for kids with more than 70 participants. We organized a Storm Drain Marking program to raise awareness about protecting water quality in urban areas. 146 volunteers marked 936 drains and distributed 1,716 educational door hangers. We also held a very popular water quality cruise on the Maumee River.
