Partners for Clean Streams obtained a grant from the Ohio EPA's 319 program to work with partners to develop four regional watershed plans. The watershed plans help identify specific problem areas in local waterways that are impacting the health of the stream, nearby habitat, and wildlife populations. Specific projects from many partners are proposed in the plans. Developing these plans, and getting them approved by Ohio EPA, allows partners to apply for future grant funding that will benefit the community.

Partners for Clean Streams continued to support the Maumee Area of Concern Advisory Committee and its activities with a grant from Ohio EPA. We planned meetings, continued improving an online data management tool, and organized many community education & stewardship programs. We organized tours of local projects that improve habitat & wildlife populations that we helped leverage funding to support. We created & shared videos & social media content to inform the public. We led 16 stream cleanups & assisted with three large storm drain marking programs with youth.
